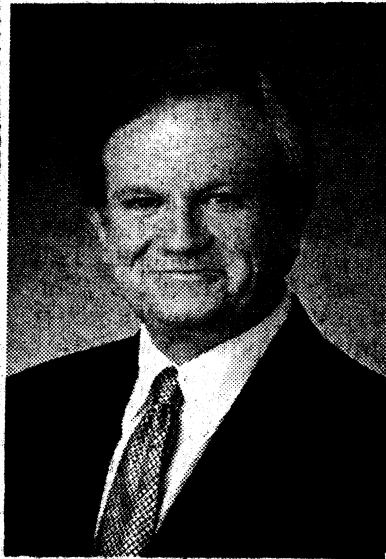

**WILLIAM DANIEL
"DAN" JULIAN III**

Mr. William Daniel "Dan" Julian III, age 54 of Crockett, passed away Sunday, April 24, 2005 in Houston. The progeny of two pioneer Texas families. Mr. Julian was born August 3, 1950 in Crockett and was the second child and only son of Madeline Belle Drury Julian and W. Julian Jr.

Mr. Julian attended the Crockett Public Schools, and graduated, with honors, in 1968. Mr. Julian entered the University of Texas at Austin, where he joined and was active in a leadership role in the Pi Kappa Alpha social fraternity. During his college years, in addition to his studies, he held varied jobs including Sergeant-at-Arms at the State Capitol, waiter, bus boy, census taker, parking lot attendant, and Santa Claus.

Mr. Julian received a B.A. Degree in 1973 with a double major in Government and Advertising. From 1973-1975 he served on the staff of Price Daniel, Jr., then Speaker of the Texas House of Representatives and President of the Texas Constitutional Convention.

In 1975 he entered South Texas School of Law in Houston. Was a member of the South Texas Law Journal, serving on the editorial board as a Technical Editor, and a

member of the Order of the Lytae and Phi Delta Phi legal fraternity as well as Associate Justice of the Honor Court and was selected as an Outstanding Student.

In 1977 he was selected for an internship with the Houston law firm of Sheinfeld, Maley & Kay, which he later joined after law school, becoming a Participating Associate in 1984. As a bankruptcy lawyer he represented a wide variety of both Debtor and Creditor clients and traveled extensively. Major clients included Wein Air Alaska, Continental Airlines, Detroit Texas/Southwest Gas Gatherer Systems, Allied Bank, Bank Texas, and Kwik Copy Corp., among others. In 1987 he returned to Crockett for two years to handle matters for his family. In 1991 he became in-house counsel for Bonnett Resources Corporation, a Bank One Company. Again he traveled extensively, handling a number of high-profile cases during that period.

From 1995-1996 he relocated to San Angelo to work on a capital murder defense team with a close friend and colleague, the Honorable Randol L. Stout. From 1990-2001 he also continued to work with friends and colleagues Athur L. Moller, Jr., and David B. Foltz, Jr., at David B. Foltz, Jr., and Associates in Houston. In 1993 he joined Myron M. Sheinfeld and David Foltz to establish the Arthur L. Moller Chair of Bankruptcy Law and Practice at the University of Texas Law School, to honor his dear mentor, colleague and friend. This effort created one of only two such chairs in the country, and raised over \$600,000 from the legal community and beyond.

Despite his professional and personal travels, his heart always stayed with his home in Crockett, where his family had contributed to the civic and social life for generations. In
